



HEERF II & III Emergency Student Financial Aid Grants

East West College of the Healing Arts (EWC) was given the opportunity and has chosen to participate in receiving and disbursing emergency financial aid grant funding under the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA). EWC has completed and filed an agreement with the US Department of Education (the Department) to use 100 percent of the funds received under Section 314(a)(1) of the CRRSAA Act to provide Emergency Financial Aid Grants to students.

The total amount of funds that the EWC will receive from the Department under Section 314(a)(1) is \$167,217

The total amount of Emergency Financial Aid Grants that were distributed as of June 30, 2021 was \$96,482.96.

There are 109 EWC students that are eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.

There are 52 EWC students who have received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Act as of June 30, 2021.

East West College contacted the currently enrolled students with a valid 2020-2021 FAFSA application on file with the school who were determined to be eligible for Pell grants based on the estimated family contribution calculation on the FAFSA application. Eligible students were sent an email with a survey asking them to indicate the areas of financial need due to the COVID-19 pandemic and with an opportunity to indicate the level of financial need in each area.

As of April 2021, students who responded to this survey were awarded the maximum Pell grant award per their current schedule in the massage therapy program. The awards totaled an amount of \$86,773 that was issued directly to the surveyed students.

As of June 30, 2021, East West College continues to distribute to students eligible under the federal Title IV programs who had dependents, notification of reimbursement available for childcare costs. This is through September 2021. Eligible students were notified by email to submit receipts for reimbursement.

Currently attending students, who were determined to be Pell eligible from the 2020-2021 FAFSA application, were contacted with a survey asking them to indicate the areas of financial need due to the COVID-19 pandemic and with an opportunity to indicate the level of financial need in each area. Students who responded to this survey were awarded the maximum Pell grant award per the massage therapy program at $\frac{3}{4}$ time attendance. This utilized a total of \$9,709.96 issued directly to the surveyed students, as well as exhausting the school's remaining student CARES grant funding.

The college plans to continue to distribute additional grant funds directly to students to assist in PPE costs for those who continue to be eligible under the federal Title IV programs, verifiable through a 2020-2021 (21-22 following July 1, 2021) FAFSA application.

Students are also invited to contact the EWC Financial Aid, Student Accounts or Student Services staff directly, with any questions regarding the Emergency Financial Aid Grants or their educational and personal situations.

As of September 30, 2021, there are 114 EWC students that are eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.

There are 70 EWC students who have received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Act as of September 30, 2021.

East West College continues to distribute to students eligible under the federal Title IV programs who had dependents, notification of reimbursement available for childcare costs. This was through September 2021. Eligible students were notified by email to submit receipts for reimbursement.

Currently attending students, who were determined to be Pell eligible from the 2021-2022 FAFSA application, were contacted with a survey asking them to indicate the areas of financial need due to the COVID-19 pandemic and with an opportunity to indicate the level of financial need in each area. Students who responded to this survey were awarded the maximum Pell grant award per the massage therapy program at $\frac{3}{4}$ time attendance. This utilized a total of \$29,027 issued directly to the surveyed students. This also included 2 one-time awards, determined by need of the student's situation through FSA PJ requests, which did not deem the student with a financial detriment large enough to effect Pell eligibility.

The college plans to continue to distribute additional grant funds directly to students to assist in PPE costs for those who continue to be eligible under the federal Title IV programs, verifiable through a 2021-2022 FAFSA application.

Students are also encouraged to reach out to the EWC Financial Aid, Student Accounts or Student Services staff directly, with any questions regarding the Emergency Financial Aid Grants or their educational and personal situations.

East West College of the Healing Arts (EWC) was given the opportunity and has chosen to participate in receiving and disbursing emergency financial aid grant funding The Higher Education Emergency Relief Fund III (HEERF III) which is authorized by the American Rescue Plan (ARP), Public Law 117-2, signed into law on March 11, 2021. EWC has completed and filed an agreement with the US Department of Education (the Department) to use 100 percent of the funds received under Section 2003(a)(4) of ARP to provide Emergency Financial Aid Grants to students.

The total amount of funds that the EWC will receive from the Department under Section 2003(a)(4) is \$100,904, which brings the total of the HEERF student grant funds total to \$268,121.

As of December 31, 2021, there are 140 EWC students that are eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.

There are 31 EWC students who have received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Act as of December 31, 2021.

East West College continues to distribute to students eligible under the federal Title IV programs who had dependents, notification of reimbursement available for childcare costs. This was through December 31, 2021. Eligible students were notified by email to submit receipts for reimbursement.

Currently attending students, who were determined to be Pell eligible from the 2021-2022 FAFSA application, were contacted with a survey asking them to indicate the areas of financial need due to the COVID-19 pandemic and with an opportunity to indicate the level of financial need in each area. Students who responded to this survey were awarded the maximum Pell grant award per the massage therapy program at $\frac{3}{4}$ time attendance. This utilized a total of \$57,173.72 issued directly to the surveyed students. This also included 2 one-time awards, determined by need of the student's situation through FSA PJ requests, which did not deem the student with a financial detriment large enough to effect Pell eligibility, as well as reimbursement for childcare costs through submitted receipts.

East West College of the Healing Arts continues to distribute emergency grants to eligible students under the HEERF III grant funds and has fully exhausted the original HEERF II fund total of \$167,217, through Fall 2021 grants issued.

The college plans to continue to distribute additional grant funds directly to students to assist in PPE costs for those who continue to be eligible under the federal Title IV programs in addition to future direct to student grants in the W122 term, verifiable through a 2021-2022 FAFSA application, with the remaining \$80,462.73 in HEERF II/III grant funds.
